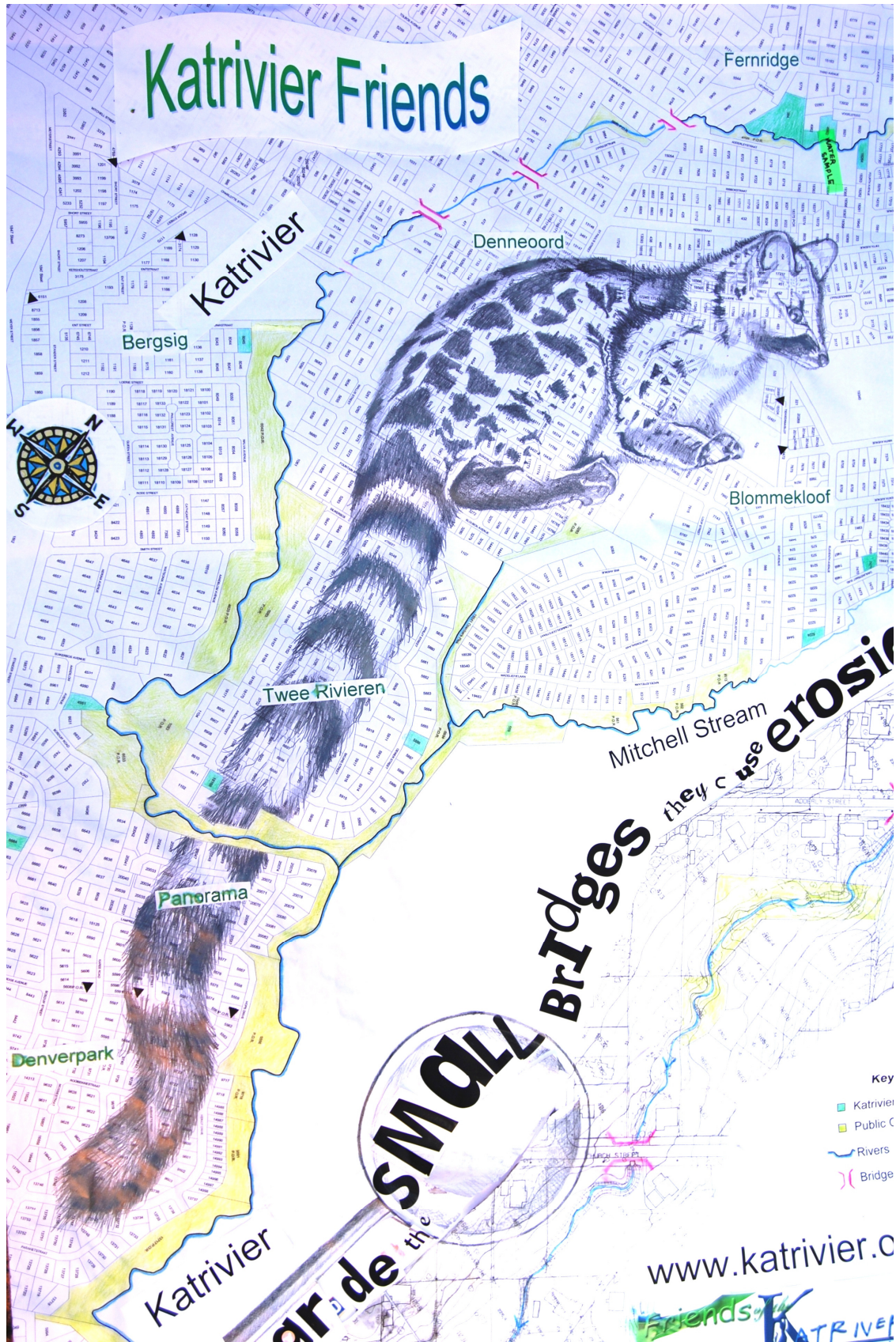

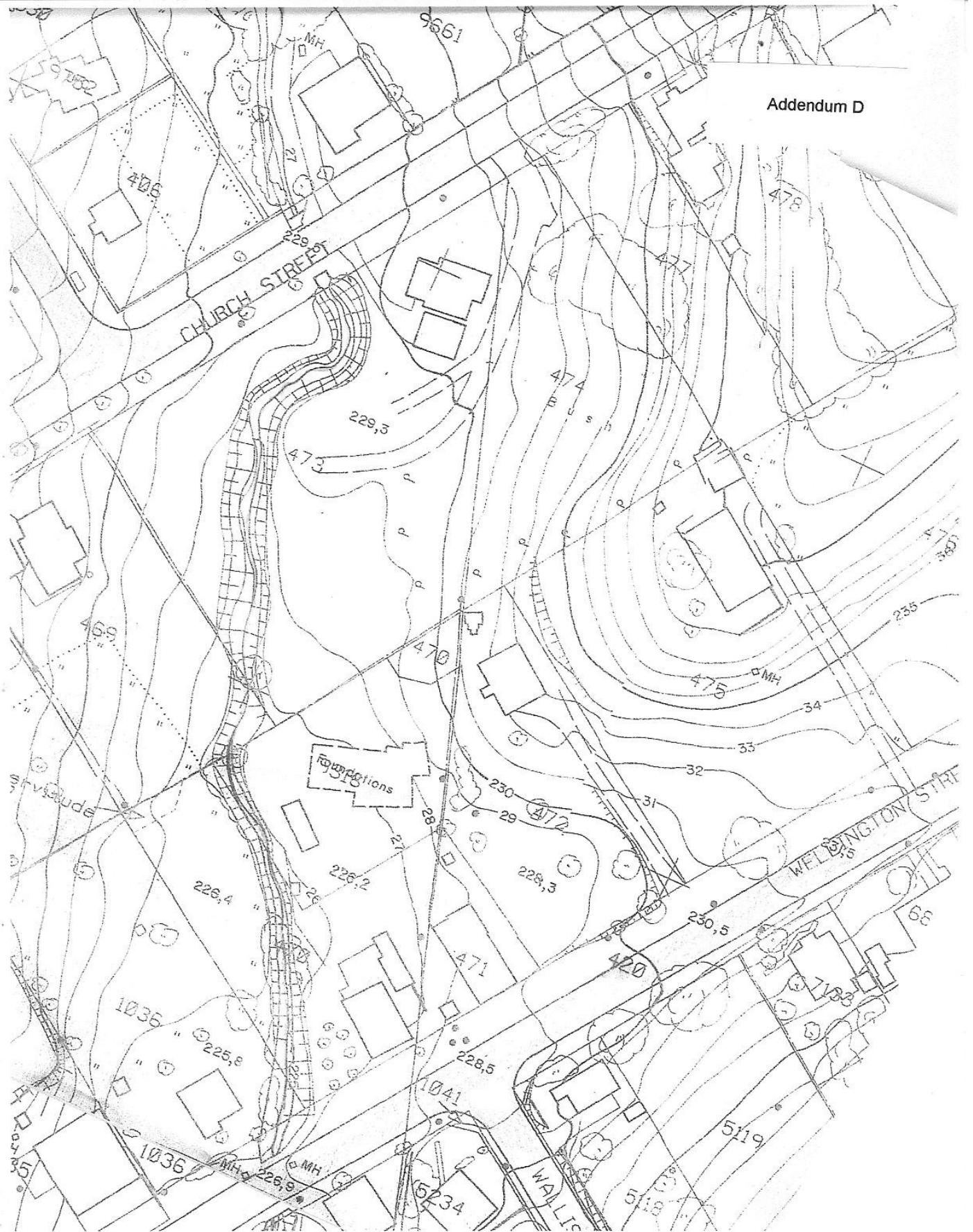


Yellow Green Area indicates Nature reserve

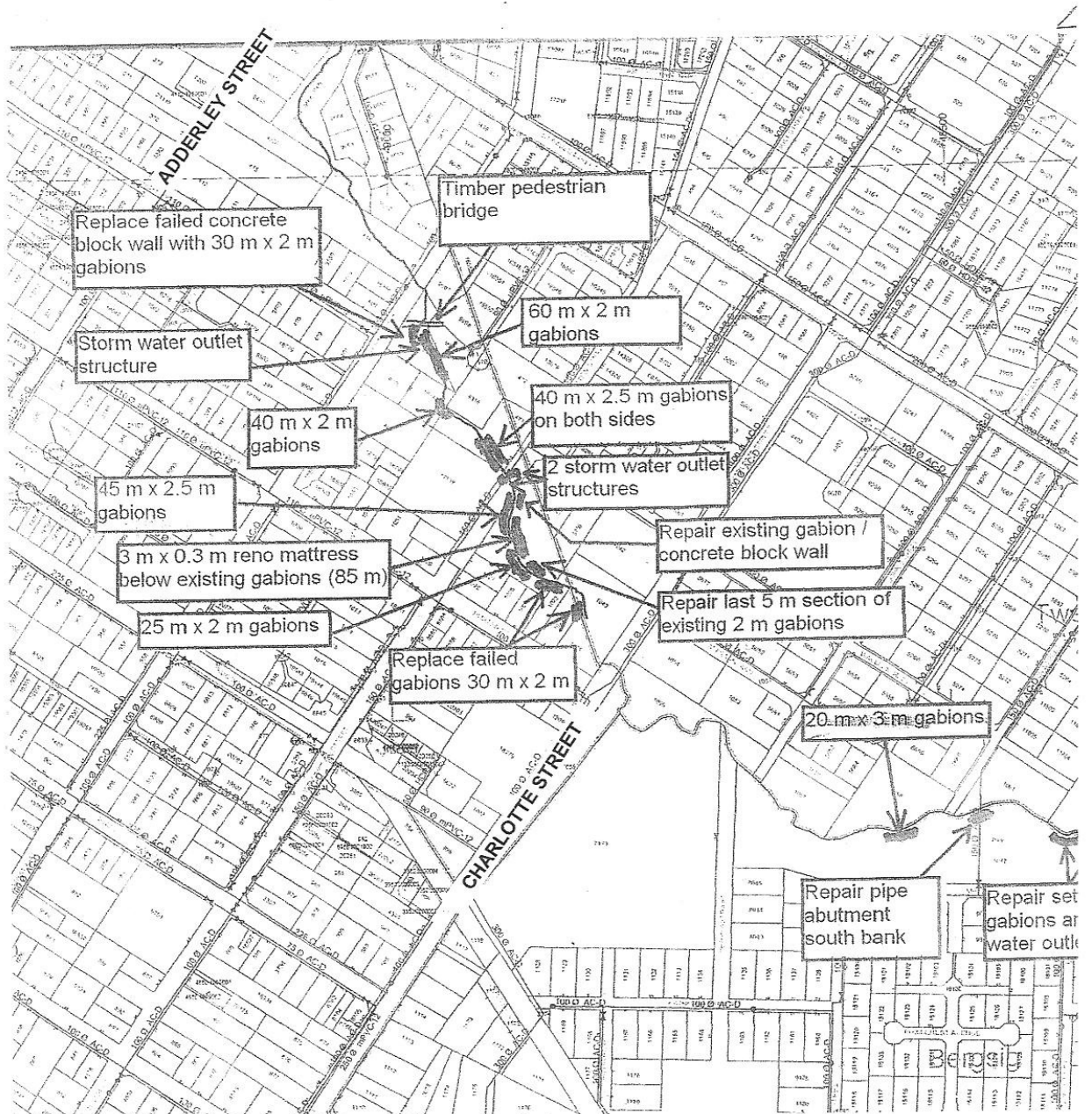
